Thank you for helping us create recreational opportunities for the citizens of Niagara Falls. The following information will explain the procedure which is involved in processing your application and issuing you a permit.

Once your applications have been received by SCVFA, it will be processed and a permit will be issued during the first week of the month during which your event has been approved.

Claim/losses/damages/judgment/injury

By signing an application form, the applicant indemnifies and saves harmless the Stamford Centre Volunteer Firemen's Association against all losses, claims, demands, actions, costs and judgment brought against, suffered by or imposed on its property in respect of any loss of theft of anything belonging to the applicant or anyone attending the event, damage, injury, including injury resulting in death, to any person or property, during the applicant's use of the facilities.

NOTE: Any documentation submitted to the SCVFA is subject to the freedom of information and protection of privacy act.

Picnics (family groups) per day, per pavilion or designated area.	\$50.00
Picnics (company & charitable organizations) per day Non-profit per pavilion or designated area.	150.00
Commercial or School Events With entrant fees and\or vendors---per day (to be determined by how big an area desired).	1250.00
Without vendors or entrant fees---per day	200.00
Weekday-all day usage--per month	1500.00
Special Events (i.e. weddings, photo-ops)	75.00
Hydro use (commercial events)---per day	15.00

APPLICANT AGREES:

To submit a \$50.00 deposit over and above the fee to cover (if any) of the following:

A: To pay for any damages to park property or equipment.

B: To pay for any extra cleaning costs resulting from misuse of the park or facilities.

C: To pay for the removal of trash left behind.

D: To pay for not returning key(s) to Dave D'Orsay, as promised, for replacement.

E: To provide proof of insurance in the amount of \$1,000,000.00. (A copy of the front page of permit holder's policy is acceptable).

F: Not to have alcohol on the premises without a permit. It is understood all conditions of the LCBO will have to be met.

G: To pay registration fee prior to the event. **NO EXCEPTIONS!**

H: To indemnify the SCVFA from all manner of claims and actions arising from the use of the facility.

It is understood that this permit may be cancelled by the SCVFA if there are any violations of the above.
